DOG ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

Condition of the Dog. Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the Fetch test. Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs are allowed to enter so long as the handler is in control of the dog at all times, the dog can complete the requirements of the test, and the dog does not appear to be under undue stress in the opinion of the judge.

No entries will be accepted by phone, email, or fax. Express mail entries must include the signature waiver allowing them to be left at the secretary's address. Sign-In

EXHIBITOR CHECK-IN: Please check in at the Secretary table. You will receive a Judging sheet to complete. You will be responsible for handing this sheet to the Judge upon entering the ring. **Exhibitors MUST check-in EACH day they are entered.**

Spectators

Spectators will be allowed as long as no interference is created with the test procedure. (Judge's Discretion)

Photography

Ringside cellphone photos/videos will be allowed as long as no interference is created with the test procedure. (Judge's Discretion)

ADDITIONAL SITE INFORMATION

The Fetch events will follow the rules set forth by KOTC Fast Cat event.

- Dogs should be warmed up before and cooled down after running.
- ALL DOGS RUN AT OWNER'S SOLE RISK
- All dogs must be on leash at all times except while actively testing. **Dogs must enter and exit the test area with the leash attached to the collar.**
- All AKC rules regarding sportsmanship and conduct apply.
- This is a rain-or-shine outdoor event. Please plan accordingly. Please bring your own shade, chairs and water.
- The show grounds are *not* completely fenced. *The FETCH course WILL be fenced.*
- A \$5 fine will be assessed for any loose dog on the field not competing, or an exhibitor caught not picking up after their dog.
- You are responsible for controlling your dog(s) and children.
- Bitches in season and lame dogs will be excused.
- Dog(s) and/or person(s) exhibiting conduct detrimental to the AKC will be asked to leave the trial site by the Event Committee and may be disciplined by the AKC. Entry fees will not be refunded.
- No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club.
- The event-hosting club, its agents, members, representatives, volunteers, etc., assume no liability or responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The American Kennel Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The American Kennel Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the American Kennel Club or any official thereof.

Collars, Leashes, and Harnesses. Dogs must wear a collar. Dogs may wear slip collars, buckle collars, and Martingales in the AKC Fetch test. They may not wear prong collars, e-collars, head collars, muzzles, or body harnesses. Leashes should be 4 ft. to 6 ft. long and should be made of fabric, leather, or biothane.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Please be aware club may ask for proof of rabies vaccination if any incidents occur.
